

PREAMBLE:-

Whereas it was unanimously resolved by the Executive Committee of the Bharathi Education Society (R) Bharathinagar (K.M.Doddi) Maddur Taluk, Mandya District, in its meeting held on Saturday the 11th May 1985, after carefully considering the letter dated 1.4.85 of Sri H.Kendegowda, one of the members of the Executive Committee, that the said Education Trust (R) Bharathinagar (K.M.Doddi) and that the founder president Sri G.Madegowda M.L.A. Kiragaval be empowered to take appropriate and suitable measures to implement this resolution as early as possible.

Whereas in pursuance of the above resolution of the Executive Committee of the Bharathi Education Society (R), the General Body meeting of the said society in its meeting held on 31.5.85 unanimously resolved that the Bharathi Education Society (R) be ~~converted into~~ <sup>declared as</sup> Bharathi Education Trust (R) and that in recognition of the invaluable services rendered by him to the cause of education in the K.M.Doddi area for nearly two and a half decades, Sri G.Madegowda M.L.A. the founder-President of the Society be the Chairman of the Trust during his life-time and he be given full powers and freedom in the choice of the members of the Board of Trustees, in the determination of the strength of the Board of Trustees and also in setting forth the objects of the Trust etc., and thus to bring into existence, the Bharathi Education Trust (R); in accordance with the provisions of the Trust Act in force.

THE DECLARATION OF TRUST

In exercise of the powers conferred upon me by the Executive Committee and the General Body of Bharathi Education Society (R); as the SETTLOR the Declaration of Trust is made this 5th day of June nineteen hundred and Eighty five by Sri G.Madegowda residing in Bandigowda lay-out, Mandya City, herein after refered to as the Chairman of the Board of Trustees, Bharathi Education Trust.

Whereas the properties described in the schedule, below (hereinafter refered to as the schedule property) is the property belonging to Bharathi Education Society (R) on which the Chairma n of the Trust has full powers of ownership and disposal. Whereas the income from the Schedule property is to be utilised exclusively for the benefit of the aforesaid Trust.

Whereas the Chairman of the Trust is desirous of making a permanent arrangement with regard to the said properties as also the said institutions and intends to assign the said property in Trust for the purpose of the said institutions.

Now this deed witnesseth that the Chairman hereby conveys transfers, and assigns to the Board of trustees (hereinafter called the first trustees) the aforesaid schedule property to hold the same for the best use of the Trust upon the following terms namely:-

1. Name of the Trust:-

The Trust shall be called Bharathi Education Trust (R) Bharathinagar (K.M.Doddi).

2. Aims and objects:-

- a) To advance the cause of education and the widespread diffusion of knowledge particularly among the people of rural areas.
- b) To provide agro-based technical and education facilities in addition to general Educational facilities. To achieve this end, the trustees may start, run and continue educational institutions.
- c) To start and run nursery, Primary and Middle Schools. To further advance the cause of education by establishing high schools and colleges for the benefit of the student community of the rural parts.
- d) To provide boarding and lodging facilities to as many students as possible by establishing and maintaining paying hostels.
- e) To establish, maintain and manage library, reading rooms, and play grounds for the benefit of the students studying in the institutions run by the Trust.
- f) With a view to prevent the fast decaying of our national culture, due to western influences, the Trust may undertake the construction and maintenance of temples and similar institutions without prejudice to the secular ideal enshrined in the constitution of our mother land.
- g) To advance loans, scholarships and other monetary benefits to the poor and needy students studying in higher classes.
- h) To accept donations, grants, presents and other contri-

butions and to deal with the same for the purpose of the trust.

1) And to discharge all other lawful acts incidental and conducive to the fulfilment of the above objects set forth in the document.

3. Board of Trustees:- The Trust shall have a Board of Trustees consisting of the following fifteen members nominated in good faith by the Chairman for the purpose of management of the Trust.

3. a) The following members shall be the first trustees

b) The first trustees hereby accept the Trust.

c) Sri G. Madegowda shall be the Chairman during his lifetime and after him his successor to be chosen from among the remaining members of the Board of Trustees.

d) Any vacancy in the office of the trustees, other than the Chairman shall be filled up by the Chairman of the Trust.

e) A trustee who absents himself from three consecutive ordinary meetings shall automatically and IP SO FACTO

cease to be a trustee; provided that the trustee on request in writing is granted leave of absence by the Chairman, for a satisfactory reason.

- f) A trustee on becoming a bankrupt or remaining out of India for more than a period of 12 Calendar months shall *IPSO FACTO* cease to be a trustee.
  - g) A trustee may retire from the trust on giving a notice in writing addressed to the Chairman, of his intention to do so.
  - h) If a trustee acts or does any act prejudicial or adverse to the interest of the Trust, he or she may be removed by the Board of trustees by a majority of not less than two thirds of the total members of trustees present and voting.
4. a) The Chairman of the Trust may appoint honorarily or employ a Secretary from among the trustees and also such other Officers from outside the trustees when necessary for carrying out the purpose of the Trust and the Chairman shall also have be power to remove them.
- b) The Board of Trustees may engage the services of such servants and staff on such salaries as the Trust thinks fit and remove or replace them when and if necessary.
- c) In the day-to-day administration of the Trust in general, and the Educational institutions it runs in particular, the Chairman of the Trust is empowered to take suitable disciplinary action, such as warning, fining, suspending and even dismissing the erring officials and servants, for dereliction of duty, for misconduct, for disobedience etc., subject to the approval of the Board of Trustees.
5. a) The Trust shall have the power to frame rules and regulations and to establish its own procedure relating to the meetings

of the Trust and efficient management of the Trust from time to time.

- b) The Trust shall have full powers to make, amend and alter, rules and bye-laws, made by it, for the best management of the trust.
6. a) The Chairman and the Secretary at the instance of the Chairman, shall call for a meeting of the Board of Trustees not later than every 2 months for the purpose of transacting the business of the Trust.
- b) Nevertheless, the Chairman may in his discretion call for an urgent meeting for transacting urgent and unforeseen matter; as and when they arise.
- c) Should the Chairman fail to convene a meeting after the clear lapse of a period of two months from the date of the previous ordinary meeting, it shall be open for any three of the members of the Board of trustees to send in a requisition in writing for holding a meeting and if within one week from the date of such requisition, the Chairman of the Trust fails to convene a meeting the trustees may call for and hold a meeting and transact business of the Trust.
- d) The quorum for a meeting, whether ordinary or urgent shall be three and any meeting adjourned for want of a quorum, the trustees present at such adjourned meetings may proceed and transact business regardless of the quorum.
- e) Not less than seven clear days notice previous to the date of an ordinary meeting shall be given and in cases of adjourned and urgent meetings, three days notice shall be given.
- f) Provision is also made to obtain decisions on urgent matters, urgency being decided upon by the Chairman

by circulating the papers among the members of the Board of trustees, subject to rectification of such decisions at the very next meeting.

- g) The Chairman shall have the prerogative of presiding over all meetings of the Board of Trustees. Only in his absence, a member of the Board of Trustees present at the meeting may be elected as the president for the particular meeting.
- h) In all matters the decision of the majority of members present and voting shall prevail and be binding on the majority and those absent from the meeting. In the case of a tie, only the matter shall be decided by the casting vote of the Chairman.
- i) The proceedings and the minutes of the meeting shall be recorded in a book specially and exclusively kept for the purpose and shall be duly signed by the Chairman or the President of the meeting. All proceedings and minutes shall be duly read out and recorded at the very next meeting even before the subjects on the agenda are taken up.
7. a) The Chairman shall regularly maintain or cause to be maintained, proper books of accounts, proceedings of the meetings, To and From Registers, correspondence, receipts and vouchers for all payments made etc. The Accounts shall be audited by a professional, qualified and competent Auditor once a financial year as in vogue.

- b) The Bharathi Education Trust (R) as a successor body to the Bharathi Education Society (R) is entitled to open, maintain or continue bank accounts in any bank or banks as it considers fit, from time to time. The Board of Trustees may pay or cause to be paid any monies constituting part of the Trust properties or the income thereof to the credit of any such account or accounts and either by means of fixed deposits or current accounts or any other accounts as the Trust deems fit.
- c) All such accounts shall be only in the name of the Chairman of the Board of Trustees and shall be operated by the Chairman. However, the Chairman may be pleased to share the responsibility jointly with any other member of the Board of Trustees, called the Secretary.
8. a) The Board of Trustees, as a corporate body shall hold the schedule property as trust property and deal with the same as trust property only. Any property acquired hereafter from out of the income of the property or by donations, grants and gifts etc. shall also become the property of the Trust and dealt with as such. It shall be the obligation of the Trust to use its properties in pursuance of and for the promotion only of the objects of the trust as incorporated in this act.
- b) If it becomes absolutely necessary to alienate any immovable property in the best interests of the Trust, and only to add to the assets of the Trust, the Board of Trustees may authorise the Chairman to part with such property and to take immediate steps to replace the same with a more valuable asset to the Trust.

- c) Investment Clause:- The funds of the Trust shall be invested in the modes specified under the provisions of Sec.(13)(1) (d) read with see 13(5) of the Income Tax Act 1961.
- d) Dissolution Clause:- In the event of dissolution or winding up of the Trust the assets remaining as on the date, under no circumstances be distributed among the members of the Board of Trustees, but the same shall be transferred to another charitable trust, society, association or institution whose objects are similar to those of this Trust and which enjoys recognition under 80G of the Income Tax Act.
- e) It shall be lawful for the Board of Trustees to make such arrangements for the better management of the Trust properties not inconsistent with the objects of the Trust.
- f) Any alterations, changes or amendments made to the rules or bye-laws of the Trust will not be repugnant to the provisions laid down in Section 80 (g) of the Income Tax Act of 1961.
- g) The members of the Board of Trustees shall at all times be bound by the provisions of Trust Act, in force from time to time and shall be liable for any misdemeanour, misconduct or misapplication with regard to their function as trustees or to the Trust properties.
